Farmers Market Vendor Rules

Section 1

- 1. The 2024 market will be open every Saturday, June 14, through October 4, from 8:00a.m. to 1:00 p.m. Vendors are encouraged to set up prior to the 8:00 a.m. start time.
- 2. Season stall renters reserve their space for the entire season. Season stall renters must be in their place at 8:00 a.m. on Saturdays, every market day or their stall will be considered open for the day and may be rented to a daily renter. If a seasonal vendor misses 3 consecutive markets without contacting the Market Manager (may lose their space).
- 3. All vendors are required to meet all applicable food safety rules and licensing regulations of the County of Newaygo and the State of Michigan. If you are unsure if you meet the guidelines, please contact: (616) 293-4727
- 4. All vendors must display a sign with a name and address clearly visible to the public. No produce, displays, etc. will be allowed outside your own area.
- 5. No animals are permitted at the Market except to assist individuals with disabilities.
- 6. No subletting of your vendor stall is allowed during the market season. Space cannot be reserved without advanced payment. One vendor can reserve up to four stalls and vendors cannot lease or rent their reserved stall(s) to other vendors.
- 7. All vendor vehicles driven on the market site must be operated in a safe and prudent manner. Vendors are allowed only one parking spot. Extra parking may be available in the lot behind City Hall for additional vehicles.
- 8. The Fremont Farmers Market does not intend to set vendor prices. However, vendors will keep in mind that this is a retail market, not a wholesale market. Please establish a fair retail price. Vendors will not practice distress pricing.
- 9. Each vendor stall must be under the "on-site" supervision of a responsible person 16 years of age or older.
- 10. Any seller, daily or seasonal, in violation of these rules is subject to suspension as determined by the Market Manager. Violators shall forfeit rental of stall.
- 11. All vendors generated waste; rubbish or trash must leave the market with the vendor.
- 12. All stall renters must clean the area they occupy prior to leaving. (Must be broom clean)

Section II

- 1. All prepared food must be pre-packaged, handled, stored, offered by sale, and sold in a manner to protect package from contamination.
- 2. All produce must be fresh, high quality, in season, and Michigan grown. "All food and produce not grown by a vendor, (i.e., that was purchased from another Michigan grower) must be labeled as such."
- 3. Fremont Farmers Market does not permit the sale of livestock, flea market items, or antiques. However, crafts from nature are acceptable.
- 4. All products offered for sale on the market will be open for inspection by the market management and state food inspectors. Bakeries must be licensed by the Michigan Department of Agriculture, unless for one-time or occasional sales.

5. All goods offered for sale by weight must be weighed on approved scales in full view of purchaser if requested.

Section III

- 1. Assignment of stall spaces shall be made by the Market Manager. Stall renters may not move to another space without the permission of the Market. The Market Manager reserves the rights for assignment to consider a balanced placement of various vendors for the good of the market.
- 2. Reservations can be made for daily stalls by calling the Fremont Market Manager (231) 519-9318. Daily renters must report to the Market Manager in person prior to each market day that they wish to sell.
 - a. Daily stall assignments will be made based on "first come, first served."
- 3. Overt sales tactics and "hawking" is not allowed.
- 4. Complaints or appeals concerning the actions of the Market Manager may be made in writing to the Fremont Area Chamber of Commerce, 7 E. Main St. Fremont, MI 49412.
- 5. All checks and money orders are made payable to Fremont Area Chamber of Commerce
- 6. Cancellation Policy of paid booth spaces are as follows: 30 days prior to opening of the market, vendors will receive a full refund of pre-paid fees. After the 30-day period, vendors will receive a refund of prepaid fees minus \$10.00 for each day present at the market plus a \$25.00 cancellation fee.
