### **Entry Deadline:**

- All applications must be submitted to the Fremont Area Chamber of Commerce (FACC) by Friday,
   December 5, 2025.
- Late entries may incur a \$50 processing fee.

#### Forms:

• Please remove and keep this information sheet. The Parade Entry Form and Announcement Form must be submitted online so announcers can accurately describe your entry. Be sure to include details about your organization and participants.

### **Parade Day Schedule:**

- Registration: Begins at **4:00 PM** at the corner of E. Maple St. & S. Darling Ave.
- Registration Deadline: 5:30 PM late arrivals will not be admitted
- Parade Step-Off: 6:00 PM
- Route: E. Maple St.  $\rightarrow$  right on S. Merchant St.  $\rightarrow$  left on E. Main St.  $\rightarrow$  ends at Weaver Ave.

#### **Parade Guidelines:**

- Only one live Santa Claus (provided by the Chamber) is allowed.
- Each entry should feature at least 1,000 lights.
- Include lighted signage on the front or both sides with your group's name.
- Portable generators/compressors/inverters must be securely mounted, with at least 12" clearance from combustible materials.
- For safety, the driver of a vehicle may not distribute candy. Walkers may distribute candy or small items.
- No entries promoting social issues or controversial topics.
- Equestrian units must provide their own clean-up crew.
- No alcohol may be consumed or displayed.
- Only the registered vehicle may enter the staging area—please load participants beforehand to ensure everyone's safety.
- If using large farm equipment or semi-trailers, note this on your application.
